	Cashier Check #419552439 was drawn from account 00143-41694 according to a withdrawal copy given by Bank of America. We do not know whose account it is, and we could be liable for money laundering, and I reported both transactions to IRS. I wonder if the bank reported transactions to IRS, and I requested information from bank and never received it. Originator of this cashier check was <b>D. Gumbs Film</b> , and withdrawal slip was forged again by Bank of America Employee signing  **D Gumbs 7ilm.** Two approval initials —same ones as in #3 above.
