The Electric Reliability Council of Texas (ERCOT) calculates the market cost of electricity every five (5) minutes and publishes the LZ price every fifteen (15) minutes. The price will vary in the ERCOT market and can be higher or lower than term and variable rate plans. The Energy Charges listed above is the average energy charge based on the Houston Load Zone from 1/1/2018-12/31/2018 and is not guaranteed at the time of billing. The TDU provides the total monthly kWh, as well as the time-of-use interval data from your advanced smart meter.
