I have purchased over \$200,000.00 with Ebay since I joined in November 2007. So Paypal has been a part of every transaction and they seem not to know. I cannot believe the incompetent people that work there! I had a Business Account and about a week ago I called and Questioned about the Illegal charges on the Ebay Tax Money and I was sent to a Supervisor and let me tell you I put Him in the Right Place and was he squiggling like a worm? COST! I wanted to also mention that when PayPal puts your money on Hold they state Several Reasons why and one is to help Protect the seller and Buyer. PayPal, How does this Help the Seller? You Idiot! You take tour percentage and keep it and ebay gets the tax money and i have to wait on mine to come through before I can spend it. Since I am a Top Rated seller, I offer free Shipping on all of my items and free returns if something is not Describe when the Buyer receives it. So you sit on the Money along with thousands of others and making interest on it and the Seller has Paid for Shipping out of his pocket and that is a expense that should be able to take out of what I sold the item for?
