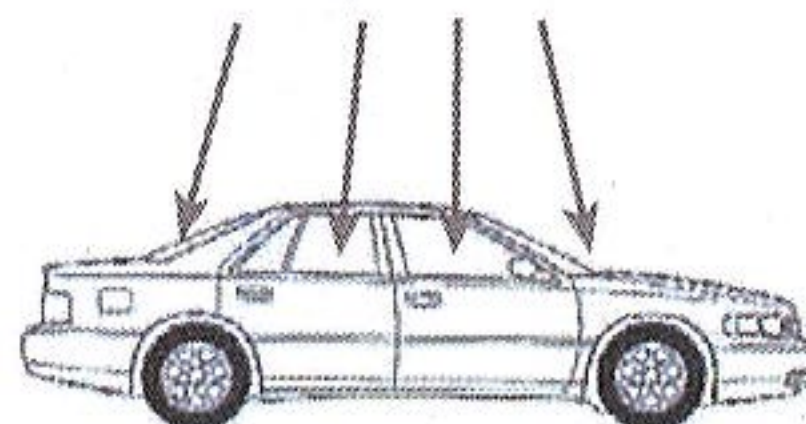

THIS AGREEMENT IS A LIMITED WARRANTY ONLY AND NOT INSURANCE. PURCHASE OF THE THEFT PREVENT RECOVERY SYSTEM IS NOT REQUIRED FOR THE PURCHASE, LEASE OR FINANCING OF A VEHICLE.

1. **PARTIES:** This limited guarantee of product effectiveness, which is not an insurance policy, is between Century Automotive Service Corporation, and you, the original owner of the registered vehicle listed herein.
2. **TERMS:** On a NEW vehicle purchase, this guarantee shall be in effect for five (5) years from the date of sale of the Theft Prevent Recovery System on the registered vehicle listed herein. On a USED vehicle purchase, this guarantee shall be in effect for three (3) years from the date of sale of the Theft Prevent Recovery System on the registered vehicle listed herein. Theft Prevent Recovery System Cost: \$299.
The benefits indicated below will be paid should your vehicle be stolen and not recovered within thirty (30) days, as follows:
3. **BENEFIT:** If the Theft Prevent Recovery System fails to prevent the theft of the vehicle listed in the registration and said vehicle is stolen with in five (5) years for a new vehicle and three (3) years for a used vehicle from the date of sale of the Theft Prevent Recovery System and not recovered within thirty (30) days, Century Automotive Service Corporation will pay the registered owner the benefit amount, which is the lesser of: (1) \$2,500.00; (2) the price you paid for the vehicle; or (3) the actual cash value of the vehicle.
4. **CLAIMS PROCEDURE:** In order to qualify for the benefit noted above, the following claim procedure must be followed:
 - a. If the registered vehicle is stolen, the original registered owner must notify and submit to Century Automotive Service Corporation 1-800-835-2025 within thirty (30) days, the following information. Failure to do so will cause this guarantee to become null and void.
 - b. Copy of police report filed within 30 days from the date of loss.
 - c. Copy of insurance claim settlement check within 30 days of date of loss.
 - d. Copy of Theft Prevent guarantee.
 - e. Proof of automobile purchase in conjunction with, and on the date of Theft Prevent purchase.

IMPORTANT: THIS WARRANTY IS NOT VALID UNLESS THE TP IS ETCHED IN THE VEHICLE WINDOWS AND ENTERED IN THE BOX BELOW.

5. **QUALIFICATIONS:** a) This guarantee can only be purchased in conjunction with, and on the date of, the purchase of the above referenced vehicle and at an authorized Theft Prevent Recovery System dealer. b) Customer must have vehicle theft insurance in force at the time of theft. c) Vehicle must be located in the United States of America at the time of the theft.
6. **TRANSFER:** This guarantee may be transferred to a second owner, one time only provided a \$25.00 transfer fee is made payable to Century Automotive Service Corporation within fifteen (15) days of the sale of the registered vehicle accompanied by copies of the new registered title and the bill of sale.
7. **RENEWAL:** This guarantee may be renewed by the original or the second owner for an additional three (3) year coverage, one time only, by contacting the original issuing dealer, and paying the renewal fee, in effect at the time of renewal, or by contacting Century Automotive Service Corporation at the number shown below, only if you are unable to contact the issuing dealer, or if you, the owner have moved out of the area where the Theft Prevent Recovery System was purchased. This applies to a renewal within the first fifty-nine (59) months of purchase for a new vehicle and within the first thirty-five (35) months of purchase for a used vehicle.
8. **INCIDENTAL AND CONSEQUENTIAL DAMAGES EXCLUDED:** Your recovery shall be limited to the benefit amount stated herein and you are not entitled to recover from Century Automotive Service Corporation, its successors, assigns, affiliates, employees, officers or agents, and you hereby expressly waive, any and all consequential, incidental or special damages, and any claims for damages to property, injuries to persons, and loss of time, profits or income.
9. **MISCELLANEOUS:** This guarantee agreement creates and limits certain legal rights. The undersigned states that he or she has read and understands this agreement, and intends to be legally bound hereby. In the event that Century Automotive Service Corporation is made party to any legal action related to or arising out of this agreement, Century Automotive Service Corporation may recover its costs and expenses (including without limitation reasonable attorney's fees) from you.
